<sup>\*</sup> Important note: for purposes of comparison, the Company advises that it started operations in April 2013 and that its contractual tariff is highly seasonal (lower in October to March and higher in April to September). Therefore, while revenues for the 9-month period ended 30 September 2014 (9 months of operations) are higher compared to the same period of 2013 (6 months of operations), the net profit is lower due to a blend of low and high tariff (while the same period in 2013 was not affected by low winter tariff) and further due to the one-off settlement of liquidated damages under the EPC Contract in 2013.
